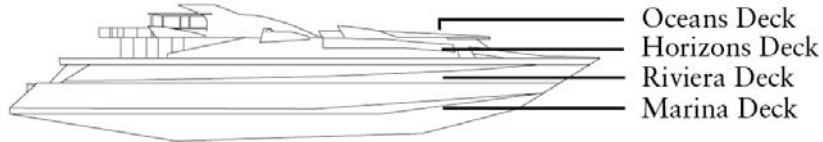


# Variety Voyager

## Currency

The euro is the official currency on board the ship. American Express, MasterCard and Visa credit cards; U.S. dollars are also accepted (personal checks and traveler's checks are not accepted). Participants may sign for beverages and purchases on board and settle their account prior to disembarkation.

The ship does not maintain a currency exchange.

## Smoking policy

The M.Y. VARIETY VOYAGER has a nonsmoking policy. Smoking is permitted only on open decks.

### *Dining*

The M.Y. VARIETY VOYAGER dining room accommodates all guests at one unassigned, single seating. Menus feature international cuisine with a focus on regional specialties. The ship's restaurant staff will do their best to accommodate special dietary requests (i.e. vegetarian, low sodium, etc.). ### *Medical Services*

Shipboard medical services and facilities are not available. The crew is trained in "First Aid," but there is no physician on board. Severe medical problems will require evacuation at the participant's expense. Participants should bring a sufficient supply of required prescription medicines and basic first aid needs, as they will not be available on board.
