

Explore Peru's rich cultural traditions, dazzling natural beauty, and pre-colonial empire while staying in luxurious accommodations from start to finish. Begin in the capital city of Lima with some of the very best of Peru, including the Belmond Miraflores Park Hotel, amaZ restaurant and the extensive pre-Columbian collection of the Larco Herrera Museum. Then cruise four nights along the Amazon—the world's largest river—aboard the beautiful *Delfin II* riverboat. Cruise the Peruvian Amazon in comfort looking for manatees, pink dolphins, caimans and over 1,500 species of birds. Kayak the river and go on night expeditions in the Pacaya Samiria National Reserve. Delve into the art, textiles, and archaeology of the Sacred Valley of the Inca, and enjoy Belmond's splendid Hotel Rio Sagrado. Visit the 15th-century Inca citadel of Machu Picchu from Belmond's Machu Picchu Sanctuary Lodge, the only property on top of the mountain next to the entrance of this UNESCO World Heritage site. Conclude your journey in Cusco, the former Incan capital city exploring the Sacsayhuaman fortress and the historic Plaza del Armas.

Study Leaders



Werner Sollors, Henry B. and Anne M. Cabot Professor of English, Emeritus, received his Ph.D. degree from the Freie Universität Berlin. He joined the Harvard faculty in 1983, taught for more than three decades, and is now the Henry B. and Anne M. Cabot Professor of English, *Emeritus*. He has also taught in Berlin, New York, Oxford, Paris, Bern, Venice, Rome, Jerusalem, Nanjing, and Abu Dhabi, and at the Cà Foscari Harvard Summer School in Venice. A Fellow of the American Academy of Arts and Sciences and Corresponding Member of the Austrian Academy of Sciences and the Academia Europaea, he is the author of such books as *Beyond Ethnicity, Neither Black nor White yet Both, Ethnic Modernism*, and *The Temptation of Despair*. He has edited more than two dozen books and coedited, with Greil Marcus, *A New Literary History of America*.

Together with his wife Alide Cagidemetro, he is currently at work on the book *Face to Face with Antiquity*, about travelers to ancient sites. Alide is Professor Emerita at the Università degli Studi di Venezia (Cà Foscari) where she served as Dean of Modern Languages and created and directed the Cà Foscari Harvard Summer School. She has taught at Harvard, Wellesley, Venice, Strathclyde, and Udine.

They have served as study leaders on HAA trips from Prague to Berlin, around the Iberian Peninsula, and to Japan by Sea. On this program Werner plans to provide the following lectures "**Mestizaje, Casta paintings, and "El Inca" Garcilaso de la Vega**"; "**Peru in old maps and early travelers' accounts**"; and "**Photographing Peru: Martín Chambi Jiménez, Werner Bischof, and Eugene V. Harris**." His wife Alide will provide context on "**Orellana and the river of the Amazons**" and "**The Conquest of Peru**."

Activity Level 3:

A LITTLE MORE TO IT

This moderately strenuous program includes a number of rigorous travel days and activities scheduled throughout the day. Travel will be by modern air-conditioned motor coach on roads ranging from modern highways to winding mountain roads, with drives approximately one to two hours. There will be three flights on commercial airlines within Peru ranging from approximately 90 minutes to two hours, along with two train rides lasting approximately two to four hours allowing us to travel more quickly and comfortably to our next destination. Busy times will be offset with time for independent exploration and opportunities to relax and enjoy the amenities at the hotels and on board the *Delfin II*.

Daily excursions involve one to two miles of walking, often in the full sun, and walking tours can last as long as three hours, including periodic stops. Some walking takes place in historic quarters, where streets are often cobblestoned and uneven, or on unpaved ground at the numerous archaeological sites and jungle trails we will visit. Some buildings will not have elevators, and you will encounter steps without handrails, so participants should be able to comfortably climb stairs without assistance.

Please be aware that the second half of the program takes place at high altitude, ranging from approximately 7,970 feet at Machu Picchu to 11,150 feet in Cusco. Many participants on this program will experience some symptoms of altitude sickness, including headache, fatigue, and insomnia; it is likely a few may experience more severe symptoms. All hotels have oxygen available for travelers experiencing symptoms of altitude sickness. Please note that higher altitudes can exacerbate health issues you may already have.

Schedule by Day

MONDAY, OCTOBER 17

Home / Lima, Peru

Depart home on flights to Lima, Peru. Settle into the Belmond Miraflores Park Hotel, set in a verdant garden, Miraflores Park is a true urban sanctuary overlooking the Pacific Ocean, near the city's cultural gems.

TUESDAY, OCTOBER 18

Lima

Begin the day with a welcome orientation, followed by a Lima city tour by motorcoach. Enjoy lunch in the Larco Herrera Museum, which houses one of the finest private collections of Moche ceramics in Peru. This evening, enjoy a private welcome reception and savor local contemporary Amazonian cuisine at one of the country's finest restaurants! The *ámaZ* restaurant was opened in 2012 by chef Pedro Miguel Schiaffano who sources sustainable ingredients from small rain forest communities with an emphasis on preservation of culture and cuisine.

WEDNESDAY, OCTOBER 19

Lima / Iquitos / Upper Amazon

After breakfast, transfer to the airport for a morning flight to Iquitos, the world's largest city that cannot be reached by road. Upon arrival, drive approximately 90 minutes by motorcoach to Nauta, with a bag lunch enroute. Embark the *Delfin II* and settle into cabins, followed by an afternoon orientation by the ship's crew. Over the next four days enjoy opportunities for kayaking, trail walks, and night safaris in the Pacaya Samiria Nature Reserve. Birders will be able to spot parakeets, macaws, cormorants, flycatchers, and more. Sharp eyes will spot sloths, monkeys, and caimans along the riverbank. And everyone can enjoy meals on board crafted with regional ingredients. In the evening, celebrate the start of your Amazon River cruise with fellow travelers during your first dinner on board. *DELFIN II* (B,L,D)

THURSDAY, OCTOBER 20

Upper Amazon

In the morning, board small motorized skiffs after breakfast and travel up the Belluda Cano creek to explore the dynamic

biodiversity of the rainforest. If conditions permit, go for a swim in a part of the river where the Amazon's famous pink dolphins frequently play. Return to the ship for lunch. In the afternoon, travel on the Dorado River, peeking into different creeks and lagoons as your guides help you look for macaws, monkeys, sloths and reptiles. Fish for the famous piranha (any fish caught will be immediately returned to the river). In the late afternoon, gather for a lecture before dinner on board. *DELFIN II* (B,L,D)

FRIDAY, OCTOBER 21

Upper Amazon

Explore the Zapote River, taking in the lush rainforest canopy and its monkeys and birds. Return to the ship for lunch on board. Continue up the Pacaya River and enjoy time to kayak. As darkness falls over the rainforest, travel by skiff through the dark waters of the river in search of caimans, frogs, and other nocturnal animals in their natural habitat. Dinner is served on board. *DELFIN II* (B,L,D)

SATURDAY, OCTOBER 22

Upper Amazon

Visit to Clavero Lake as your guides show you the diverse birdlife, including yellow-rumped caciques and graceful egrets. Return to the ship for lunch. Set out by skiff to visit the community of Puerto Miguel. Learn about the people that live on the Amazon and visit a local school and market, the latter featuring unique arts and local handmade crafts. Gather for a lecture, followed by your final dinner on board. *DELFIN II* (B,L,D)

SUNDAY, OCTOBER 23

Sacred Urubamba Valley of the Inca

Disembark the *Delfin II* this morning and transfer to Iquitos for your flight to Cusco. Upon arrival transfer to your hotel set on the banks of the sacred Urubamba River in the Sacred Valley of the Inca. Enjoy the hotel's scenic location and amenities this afternoon. BELMOND HOTEL RIO SAGRADO (B,L,D)

MONDAY, OCTOBER 24

Sacred Urubamba Valley of the Inca

Visit a traditional weaving demonstration by local textile experts at Chinchero followed by a visit to the Inca site of Moray to examine its unique circular terraces. In the afternoon, meet master ceramicists at Pablo Seminario's workshop and attend a Peruvian Paso horse demonstration. BELMOND HOTEL RIO SAGRADO (B,L,D)

TUESDAY, OCTOBER 25

Machu Picchu

Start the day in Ollantayambo, an ancient Inca archaeological site that has become a thriving town. Board the luxury Hiram Bingham train to Aguas Calientes and enjoy an in-depth locally guided afternoon visit of the incomparable ruins of Machu Picchu. As the crowds depart enjoy the peace and tranquility of this magical site until it closes at sunset. Your accommodations boast the only hotel sitting adjacent to the Machu Picchu archaeological site. Sit out on the terrace and savor Peruvian cuisine with produce grown in the Lodge's garden.

WEDNESDAY, OCTOBER 26

Cusco

Spend a free morning exploring Machu Picchu independently before departing via a Vistadome train ride to the UNESCO World Heritage site of Cusco, the capital of the Inca Empire. Check into the Belmond Monasterio Hotel located moments from the historic Plaza de Armas in an ancient monastery that has been at the heart of the city for centuries. Gather this evening for a farewell dinner in Cusco. BELMOND MONASTERIO HOTEL (B,L,D)

THURSDAY, OCTOBER 27

Cusco / Lima

In the morning visit Sacsayhuaman citadel, a walled complex constructed of enormous boulders fitted together tightly without mortar. Explore the historic Plaza de Armas and neighboring areas, where Inca streets, walls, and buildings were integrated over the centuries into colonial and then modern Cusco. Following lunch, transfer to the Cusco airport for a late afternoon flight to Lima. From here you will board your return flights home. (B,L)









The Delfin II

Delfin II is a stately riverboat, built for the express purpose of exploring deep into the Peruvian Amazon at the headwaters of this mighty river—and doing so in modern tropical style. *The Delfin II* comfortably accommodates 28 guests in 10 suites and 4 master suites. At 120 feet, the ship is perfectly sized to sail along the upper Amazon River. The top deck offers an open-air observation lounge with a bar and comfy chairs ideal for relaxing at the day's end and watching the jungle scenery glide past. The top deck's air-conditioned presentation room, where photo talks and daily recaps are held, has large picture windows on three sides. With board games, computer stations, and comfortable seating with a contemporary flair, this room is also perfect for relaxing. The public spaces offer sweeping views of the river and rain forest. Furnishings are made of sustainably harvested local rain forest wood, and the ship is decorated with handicrafts from the ribereños, native people of the wildlife preserve we explore. A gracious hotel staff makes an art of providing impeccable shipboard services.

Terms & Conditions

AA&D reserves the right to suspend services to—and to exclude from participation in AA&D programs—any person whose inappropriate behavior adversely affects the safety, well-being, and inclusion of community members.

CONTRACT: Harvard Alumni Association does not itself conduct tours, but instead partners with several different tour operators to offer a broad range of travel programs. Tour participants contract directly with tour operators, although HAA is available to act as a liaison with tour operators should participants have any questions or concerns. HAA is not responsible for performing any of the tour operator’s obligations. The tour operator for this program is Criterion Travel, based in Beaverton, Oregon.

PROGRAM COST INCLUSIONS: All accommodations and meals as specified in the itinerary; All excursions as specified in the itinerary; Full program of briefings, lectures, and presentations; Two nights at the Belmond Miraflores; Four nights aboard the *Delfin II*; One night at the Belmond Monasterio; Two nights at the Belmond Rio Sagrado; One night at the Belmond Machu Picchu Sanctuary Lodge; Scheduled group transfers on group arrival and departure days; Baggage handling; Gratuities to porters, waitstaff, guides, and drivers; Gratuities to shipboard personnel; Port charges; Entrance fees; Welcome and farewell wine reception; House wine, beer, and soft drinks at lunches and dinners; Water on motorcoaches; Professional tour manager throughout.

PROGRAM COST EXCLUSIONS: U.S. domestic and international airfare; Three on-tour flights Lima/Iquitos, Iquitos/Cusco, Cusco/Lima valued at approximately \$450; Passport/visa expenses; Medical expenses, immunizations, and any required Covid-19 testing; Travel insurance; Optional excursions or deviations from the scheduled tour; Airport transfers outside of group arrival and departure days; Airline baggage charges; Meals not specified in the itinerary;

dishes and beverages not part of the included meals; Alcoholic beverages except as noted above in inclusions; Laundry or dry cleaning; Telephone, email, and fax charges; Room service; Other items of a personal nature.

PROGRAM SIZE: This tour, (exclusively developed for Harvard Alumni Association Travels), is limited to 24 participants on a first-come, first-served basis. The minimum group size is 18. Should the minimum not be met, HAA reserves the right to cancel the program, levy a small group surcharge, and/or send the program without a Harvard study leader. HAA retains the right to add staff members and/or invited guests to any group departures regardless of the stated group-size limitation.

RESERVATIONS, DEPOSITS, & FINAL PAYMENT: To reserve a space on this program, a \$1,000 deposit is required per person. Reservations are acknowledged in order of receipt until the maximum enrollment has been reached. Final payment is due June 19, 2022 (120 days before departure), payable by check or wire transfer to “Criterion Travel”. Participants will receive an invoice directly from Criterion Travel for all subsequent payments after the initial deposit.

PARTICIPANT CANCELLATIONS & REFUNDS:

Notification of cancellation must be received in writing by the tour operator with copy to HAA from the participant.

Deposits are fully refundable until the final payment deadline of June 19, 2022. Cancellations received after June 19, 2022: All payments are 100% non-refundable regardless of deposit date.

TRIP INSURANCE: Neither HAA nor the tour operator, including all representatives, employees, and agents, will take responsibility for any costs or losses incurred or suffered by a participant, or a participant’s dependents or traveling companions before, during or after the tour. This includes, without limitation, cancellation or curtailment of the tour, emergency evacuation expenses, medical expenses, repatriation expenses, or damage/theft/loss of personal baggage, money, and goods. As noted below, neither HAA nor its tour operators shall be liable for any airline cancellation penalty incurred by the purchase of a nonrefundable airline ticket or for any other expenses incurred by tour participants in preparing for the tour.

HAA highly recommends the purchase of trip insurance to cover unforeseen trip interruptions, cancellations, lost baggage, and emergency medical

assistance and evacuation. Participants may purchase trip insurance through any provider. HAA will provide information from one provider, Redpoint Resolutions, upon confirmation, which will detail available options. If a participant purchases a trip insurance policy from Redpoint Resolutions within a 14-day window, then the pre-existing medical conditions exclusion will be waived, and the participant will be eligible to purchase the “Cancel for Any Reason” upgrade. The 14-day window begins on the first day the participant’s trip deposits become non-refundable. For participants who utilize a trip credit to book the trip, the 14-day window starts the first day the participant is subject to financial penalty for cancellation, including full or partial loss of the trip credit. An insurance policy, when issued, shall constitute a contract only between the participant and the insurance provider. HAA will not intervene in any transactional issues or claim disputes between the participant and the insurance provider.

AIR ARRANGEMENTS: International airfare is not included in the cost of the program. The tour operator can assist you with your air arrangements. Neither the Harvard Alumni Association nor the tour operator accepts the liability for any airline cancellation penalty incurred by the purchase of a non-refundable airline ticket. The air ticket when issued shall constitute the sole contract between the passenger and the airline concerned. Airfare is subject to change and availability and is nonrefundable. Your airline ticket constitutes a contract between you and the airline, even if purchased through Operator.

WHAT TO EXPECT / PHYSICAL HEALTH: Due to the prevalence of SARS-CoV-2 (COVID-19), participants should anticipate rules and restrictions to be enforced at airports, on flights, and at country entry points, as well as protocols in place during the program to reduce the risk of COVID-19 transmission. Updates will be provided closer to departure.

All participants must be in overall good health to participate in a HAA trip. All programs require physical independence and mobility: participants must be able to embark or disembark all conveyances used on the program alone or with minimal assistance from a traveling companion and must be able to climb stairs and step over raised thresholds without assistance.

Participants requiring assistance **must** travel with a companion who will be responsible for handling any required equipment. Any physical or mental health

condition that may require special medical attention or physical assistance must be disclosed in writing prior to booking so that HAA and the tour operator may evaluate whether participation is feasible. All participants should consult with their doctor about whether they can meet the physical requirements of their trip and must complete and return any medical forms required by the tour operator.

Participants with **dietary restrictions** also must make these known to the tour operator well before departure, otherwise the tour operator may not be able to accommodate them.

PREPARING FOR THE TOUR: Participants will be provided with comprehensive pre-departure travel information, including specific suggestions for packing.

CHANGES IN ITINERARY, PROGRAM, STAFFING & COSTS: The itinerary is subject to change at the discretion of HAA and the tour operator. HAA reserves the right to change program dates, staff (including study leader), itineraries, or accommodations as conditions warrant. HAA further reserves the right to cancel programs, levy a small group surcharge, send a program without a study leader and/or withdraw HAA sponsorship from a program. Please note that all participants are bound to the cancellation fee schedule and other terms and conditions of the program regardless of whether HAA takes any of these actions. Participants making deviations from the scheduled itinerary do so at their own expense. All prices quoted are based on prevailing fuel prices, airfares, and currency exchange rates in effect as of the date of this publication and are subject to change.

FAILURE TO OPERATE THE TOUR OR CANCELLATION OF THE TOUR BY THE TOUR OPERATOR: If the tour operator fails to operate the tour or cancels the tour, except as a direct result of adverse weather conditions, strikes, local laws, hostilities, wars, terrorist acts, significant health concerns (such as epidemics or pandemics requiring significant travel disruptions), or other such causes beyond HAA and the tour operator's reasonable control (Force Majeure Events), then the tour operator shall refund all monies received from tour participants. If the tour operator's failure to operate the tour or cancellation of the tour is a direct result of a Force Majeure Event, then the tour operator may provide tour participants a refund consisting, in whole or in part, of credit toward future travel. Tours also shall be cancelled if the U. S. State Department, another U.S. government agency, or a relevant local government agency issues a statement within sixty (60) days of tour departure to the effect that American citizens or others should not travel except for essential reasons to any of the destinations on the itinerary for that tour. In such case, the tour operator will provide an alternate tour with a revised or substitute itinerary and may provide tour participants who choose not to travel on the alternate itinerary a refund consisting, in whole or in part, of credit toward future travel.

CURTAILMENT OF THE TOUR BY THE TOUR OPERATOR: If a tour is curtailed after it has begun, either as a direct result of a Force Majeure Event, or because the U. S. State Department, another U.S. government agency, or a relevant local government agency has issued a statement to the effect that

American citizens or others should not travel except for essential reasons to the remaining destinations on the itinerary for that tour, then the tour operator will take immediate steps to end the tour early and assist tour participants with travel arrangements back to their homes or other final destinations. In such a case, the tour operator may provide tour participants a refund for the number of missed days on the original tour consisting, in whole or in part, of credit toward future travel. The calculation for any such refund shall take into account any non-recoverable prepayments, and any additional expenses incurred by the tour operator to wind up the tour early.

RESPONSIBILITY: The tour operator, its owners, and employees act only as agents for the various independent suppliers and contractors providing transportation, hotel accommodations, restaurants, and other services connected with this tour. Such travel, accommodations, and services are subject to the terms and conditions under which they are offered or provided, and HAA and the tour operator, along with their respective employees, agents, representatives, and assigns, accept no liability therefor. Neither HAA nor the tour operator assumes liability for any injury, damage, loss, accident, delay, or other irregularity which may be caused by the defect of any aircraft or vehicle or the negligence or default of any company or person engaged in carrying out or performing any of the services involved. Nor will HAA and the tour operator accept responsibility for losses, injury, damages, or expenses of any kind due to Force Majeure Events, other than as provided above. HAA and the tour operator may, in their sole judgment, decline to accept or retain any person as a tour participant. Baggage and personal effects are always the sole responsibility of their owners. The price of the program is given in good faith based on current tariffs and rates and is subject to change. Any increases in tariffs, exchange rates, or fuel prices will be passed onto participants. As part of the consideration and right to participate in a tour, each participant must sign this document and may be asked to sign a separate liability waiver and release form by the tour operator.

PERSONAL INFORMATION: HAA and the tour operator will not share participants' personal information with third parties or make it publicly available except as follows: participants' names, degree(s), home city, and email addresses may be included in the tour participant list that is distributed to tour staff and participants prior to departure; and relevant information about participants is shared with those contracted to provide tour services in the destination. Tour operators and their agents are prohibited from sharing or selling this information to other parties. Participants may opt out of sharing their email addresses with others on the tour participant list.

Tour participants recognize that they may be subjected to potential risks, illnesses, injuries, and even death and confirm that they have made their own investigation of these risks, understand them, and assume them knowingly and willingly. Knowing the risks described herein, tour participants agree, on behalf of their family, heirs, and personal representative(s), to assume all risks and responsibilities surrounding their participation in the tour.

RELEASE AND INDEMNIFICATION: By signing below (or by checking the respective box on the on-line registration form), I certify that I am age 18 or older and that I have carefully read and freely signed these Travel Terms and Conditions on my own behalf and on behalf of all members of my party. To the maximum extent permitted by law, I release, hold harmless and agree to indemnify Harvard, and its officers, governing board members, faculty, staff, representatives, employees and agents, from and against any present or future claims, losses, liabilities, costs and expenses for injury to person or property, or for any other damage, which I may suffer, or for which I may be liable to any other person, related to my participation in the tour resulting from any cause, including but not limited to negligence on my part or on the part of any of the released parties.

I understand and agree that no oral or written representations can or will alter the contents of this document. I agree that this agreement shall be governed by the laws of the Commonwealth of Massachusetts (excluding its conflict of laws principles), which shall be the forum for any lawsuits filed under or incident to this agreement or the tour.
